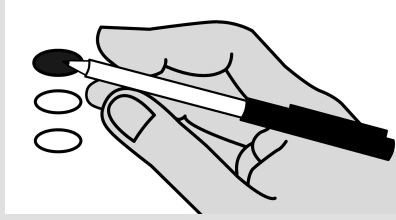

How to vote

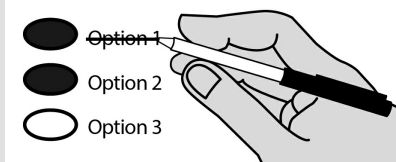


Use a blue or black ink pen.

If you vote for more than one, no votes will be counted for that race.

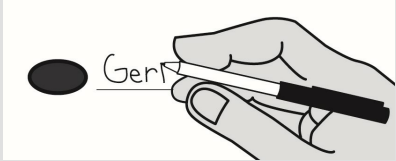
If you make a mistake

Proposition 1**

The Castle Rock City Council adopted Resolution No. 2019-02 concerning a proposition to fund public library services by special excess levy. The proposition authorizes the City of Castle Rock, Washington, to levy an excess property tax in the year of 2019 for collection in 2020 of \$0.50 per \$1,000 of full assessed value for a total assessment of \$80,949.12. The excess levy would fund maintenance and operations of the library.
