

Disposition of Enactments

This table is arranged in chronological order and shows the Code chapter number of the various ordinances, resolutions, and other enactments of the Board of County Commissioners. The table also shows the disposition (usually a repealing ordinance) of many enactments which are no longer in force. Sequential resolution/ordinance numbers are given for enactments passed since January 1, 1962, when the numbering began.
