

INTERLOCAL COOPERATIVE PURCHASING AGREEMENT

In accordance with the provisions of chapter 39.34 RCW and other provisions of law, COWLITZ COUNTY and CONSOLIDATED DIKING IMPROVEMENT DISTRICT NO. 1 OF COWLITZ COUNTY (hereinafter referred to as CDID) hereby agree to cooperative governmental purchasing upon the following terms and conditions:

- (1) Cowlitz County, in contracting for the purchase of goods and services, agrees to contract also on behalf of CDID to the extent permitted by law and agreed upon by the parties hereto.
- (2) Cowlitz County will contract for the purchase of goods and services in accordance with the laws and regulations governing purchases by the county. CDID accepts the responsibility for compliance with any additional or varying laws and regulations governing purchases by it.
- (3) Whenever Cowlitz County has contracted to purchase goods or services on behalf of CDID, or a class of political subdivisions including CDID, CDID may purchase goods and services covered by the contract on the same terms and conditions as Cowlitz County. Such a purchase by CDID may be effected by a purchase order directed by CDID to the vendor or other party contracting to furnish goods or services to Cowlitz County. Cowlitz County accepts no responsibility for the payment of the purchase price by CDID.
- (4) Cowlitz County reserves the right to exclude CDID, or any class containing CDID, from any particular purchasing contract, with or without notice to CDID.
- (5) This agreement shall continue in force until cancelled by either party, which cancellation may be effected with or without notice to the other party.
- (6) This agreement is expressly made under the provisions of chapter 39.34 RCW, as a memorandum of understanding, in contemplation of further agreements between the parties relating to specific purchases as needs arise. Both parties understand and agree that contracts with vendors pursuant to this agreement may include purchases (a) by the county acting as agent for either of both parties in securing the best bid price and terms on one or more items or kinds of property for a time period specified in such contract, under RCW 39.34.030 or 39.34.080, or (b) by the county as agent for CDID in procuring specific items of property, pursuant to a specific request made in writing by CDID, under RCW 39.34.080, or joint purchase agreements relating to one or more specific items of property, pursuant to RCW 39.34.030.
- (7) It is further understood that in all such cases the party making such purchase will comply with purchasing statutes including bid requirements applicable to both parties.

This Agreement shall be in full force and effect upon execution hereof by both of the parties hereto.
