NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Cowlitz County, Washington, will receive bids for furnishing of Snow Sand for Roads.

Sealed bids will be received by the Board of County Commissioners, Attn: Clerk of the Board, County Administration Building, 207 Fourth Avenue North, Kelso, Washington, 98626, prior to **1:30 o'clock p.m.**, the **30th day of October, 2024**, for furnishing of **3/8" screened sand** for 2024.

RCW 39.34 allows cooperative purchasing between public agencies in the State of Washington. Other public entities (cities, school districts, and so forth), which have filed an Interlocal Cooperative Joint Purchasing Agreement with the County, may elect to purchase road surfacing materials from the vendor based on the terms and conditions of this agreement, subject to vendor's consent.
