Water Quality Summary

The following report provides detailed information concerning the Toutle River View Water System which serves the Toutle River View community. This information is required to be reported to our customers by the US EPA and the Washington Department of Health. This report contains information about the results of samples collected from January 1, 2024 through December 31, 2024. The Toutle River View Water System provides domestic drinking water to 19 customers. This system met or exceeded all federal and state drinking water standards and requirements during 2024. Water Source and Treatment Information

Water Source: The water system withdraws water from a 35-foot-deep class “A” well located southwest of the original well house. This well has a rated capacity of 18 gallons per minute. Two additional wells are available as emergency sources. Each of these wells are rated at 4 gallons per minute.

Treatment: Liquid chlorine is added to the well water as a disinfectant. Sufficient chlorine is added to kill any bacteria from the well and to maintain a residual level of chlorine in the distribution system.

Sampling: Your water is sampled on a regular basis according to both State and Federal regulations, The purpose of the sampling is to ensure that treatment methods are adequate. It also ensures that harmful substances don’t exceed regulated levels and identifies if they are present or entered the water supply.

Water Quality Monitoring Results

The table below represents the analytical results of water samples collected from your system. In addition, there were no samples collected in 2024 that included a presence of Fecal Coliform bacteria. The presence of contaminants in the water does not necessarily indicate that the water poses a health risk.

Definitions

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers additional treatment measures or other requirements that a water system must follow.

Maximum Contaminant Level (MCL): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Parts for Billion (ppb): Unit of measurement that describes the levels of detected contaminants. One part per billion corresponds to a single penny in \$10,000,000.

General Information

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:



- *Microbial contaminants*, such as viruses, parasites, and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, or wildlife.
- *Inorganic contaminants*, such as salts and metals, which can occur naturally or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, and farming.
- *Pesticides and herbicides*, which may come from various sources such as agriculture, urban stormwater runoff, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production. They can also come from gas stations, urban stormwater runoff, and septic systems.
- *Radioactive contaminants*, which can occur naturally or result from oil and gas production and mining activities.

Important Information about Drinking Water

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Cowlitz County Public Works is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking
